If the priest has never served in the U.S., we have to trust the responses of the major superior and the priest. In addition, it is our understanding that the Consulate in the home country of the
						priest will not issue the R-1 Visa if the priest has a criminal record. About 6 mos. or 1 yr. after the priest has served in this diocese and gained some history, we then do the above mentioned background checks. According to our screening schedule, the checks are repeated: State Criminal check - every 7 years National Sex Offender check - every 7 years Driving Record check - every 3 years Credit check - every 7 years

A letter is sent from the Diocese of Bridgeport Episcopal Vicar for Clergy to the American consul in the priest's country of origin to inform them of the priest's plan, financial arrangements and length of stay. The foreign priest is required to obtain a Non-immigrant Religious Minister Visa (R-1). After the initial contact is made with the international priest, the priest makes a formal request to be considered for ministry in the Diocese of Brooklyn. Based on assignment availability, a letter is sent to the priest listing all the required documents that are needed. The priest needs to submit for processing an R-1 Visa, if he does not have a visa to come to the United States. One of the documents is an affidavit that is requested of the Bishop/Superior of the priest. In this affidavit, the Bishop/Superior of the priest states that the priest, "never had criminal charges brought against him", and that the priest, "not manifested behavioral problems in

If they found wanting they are sent back to Lebanon. If they pass muster, they are placed on probation for a period of three to six months with an experienced pastor to be evaluated. After one year in the United States, they are screened with a criminal background check in the state in which they reside. The Diocese of Brownsville requires from the priest's bishop or religious superior written confirmation that there are no credible allegations, past or present, against the priest, regarding misconduct with a minor. The Diocese of Brownsville makes additional inquiries with persons who know or have known the priest from current or past assignments. When priests arrive, they are given psychological screening before being given assignment or faculties to minister as a priest. The screening is designed to determine psychological well-being and also whether or not the priest has been
